Application Checklist - CHINA

How to use this checklist

1. Before you submit your visa application, use this checklist to ensure that you have included all necessary documentation to support your claims.
2. This checklist should be used to prepare documents for both applications lodged online and those submitted in paper form at an Australian Visa Application centre. Documents attached to online applications can simply be uploaded through your ImmiAccount.
3. When you are satisfied that you have correctly completed your visa application form and all of the necessary documentation is included, you should sign and date your visa application form (paper applications only).
4. Include this completed checklist, when you lodge your visa application form and all necessary documentation.

Other important information

Please be aware that the decision on your visa application may be decided on the information and documentation that you include at the time of lodgement. Additional documentation may be requested during the processing of your visa application.

Please ensure that you:

- Provide an email address on the application form as this is the easiest way to communicate with you.
- Scan and upload (online) or provide photocopies (paper application) of all official original documents to be lodged with your application. Any original documents submitted will be returned to you at finalisation. Please note that certified/notarised copies will NOT be returned.
- Attach English translations of all official documents that are in any language other than English. If you provide notarised documents, official translations will be required.

If you are applying for a Partner Visa on the basis of a de facto relationship, you will need to provide:	
• Evidence that you have been in the relationship, and living together for 12 months before lodging the application; or	<input type="checkbox"/>
• Evidence that you have registered your relationship under a prescribed state or territory law	<input type="checkbox"/>
If you are applying for a Prospective Marriage (Fiancé(e)) visa, you need to provide:	
• Single certificates for both applicant and sponsor; and	<input type="checkbox"/>
• A letter from an authorised marriage celebrant or Registry of Births, Deaths and Marriages indicating that a Notice of Intended Marriage has been lodged in Australia; and	<input type="checkbox"/>
• Evidence that the applicant and sponsor have met face-to-face as adults, and are personally known to each other	<input type="checkbox"/>
If the sponsor and/or applicant were previously married, all pages of divorce documents that show details of any child custody arrangement, or a death certificate for a previous spouse.	<input type="checkbox"/>
